1. The Head of Defence Office, joined by defence counsel, has challenged before me, in my capacity as President of the Special Tribunal for Lebanon, the refusal of the Registrar to permit him to appoint Dr Omar Nashabe as Local Resource Person for the purpose of assisting the Defence of the accused on their forthcoming trial *in absentia*.<sup>1</sup> Except in relation to one aspect entailing confidentiality protecting defence interests, the Prosecutor was permitted to participate in the process. Because of potential impact of this dispute on the fairness of the proceedings, I have decided to decline in my capacity as President to determine the dispute and have invited the Pre-Trial Judge to consider dealing with the matter.<sup>2</sup>
2. There remains the issue of the confidential status of my orders and certain filings in the present dispute for me to deal with. Having given an opportunity to the Registry, the Office of the Prosecutor, and the Defence Office to make submissions on the matter,<sup>3</sup> I am now in a position to do so.
3. All participants in the present litigation agree that for reasons of confidentiality certain redactions are required. Having considered the documents I am satisfied that the rules applicable to confidentiality status (*mutatis mutandis*)<sup>4</sup> require that certain filings or portions thereof should not be made public, at least for the time being. I allow for a short delay in making public documents or parts thereof to allow the participants in the present litigation to ensure that all necessary redactions are made pursuant to their combined submissions.
