On 23 October 2012, the Legal Representative of Victims (the “LRV”) filed the Public Redacted Version of the Response of the Legal Representative of Victims to the “Prosecution’s Submission for an Order on Re-Classification of Victims Identities and Applications for Victim Participation Status, as Confidential” (the “LRV’s Response”).<sup>1</sup>

2. The Office of the Prosecutor has drawn the Pre-Trial Judge’s attention to the fact that the LRV’s Response contains confidential information. Therefore, the LRV’s Response must be withdrawn from circulation, and the LRV must refile an amended redacted version of his response that contains no reference to this information.

**FOR THESE REASONS,**

**THE PRE-TRIAL JUDGE,**

**PURSUANT TO** Rule 115 of the Rules;

**INSTRUCTS** the Registry to withdraw the LRV’s Response from circulation and reclassify it as confidential; and

**ORDERS** the LRV to refile an amended public redacted version of his Response, redacting the information referred to in the confidential and *ex parte* annex to this Order.
