## ORDER ON PROSECUTION REQUEST FOR AN EXTENSION OF TIME TO FILE A RESPONSE TO THE LEGAL REPRESENTATIVES FIRST MOTION FOR PROTECTIVE MEASURES (ANONYMITY) OF SEVENTEEN VICTIMS PARTICIPATING IN THE PROCEEDINGS

1. The Pre-Trial Judge is seised with the "Prosecution Request for an extension of time to file a response to the Legal Representatives First Motion for Protective Measures (Anonymity) of Seventeen Victims Participating in the Proceedings (the "Request") filed on 13 November 2012.<sup>1</sup>

2. On 29 October 2012, the Legal Representative of Victims (the "LRV") filed the "First Motion of the Legal Representative of Victims for Protective Measures (Anonymity) of Seventeen Victims Participating in the Proceedings".<sup>2</sup> On 2 November 2012, the LRV filed the "Second Motion of the Legal Representative of Victims for Protective Measures (Anonymity) of Six Victims Participating in the Proceedings".<sup>3</sup>

3. The Prosecution seeks leave to file a consolidated response to the First Motion and Second Motion on 23 November 2012, the date on which the response to the Second Motion is due according to Rule 8 of the Rules of Procedure and Evidence (the "Rules"). By virtue of the same Rule, the Prosecution's response to the LRV's First Motion is due on 16 November 2012.

4. The Prosecution submits that the factual and legal issues raised in the Motions are the same, and that a consolidated response will further judicial economy.<sup>4</sup>

5. The Pre-Trial Judge observes that the issues raised by the First Motion and Second Motion are substantially the same, and justify the Prosecution's request for leave to file a consolidated response. The Pre-Trial Judge considers that the requested extension of time will not cause undue delay to the proceedings, and accordingly — pursuant to Rule 9 — grants the Request.
