- On 17 August 2012, the Prosecution filed a confidential request before the Pre-Trial 1. Judge for leave to amend the confirmed indictment pursuant to Rule 71 (A) (ii). On 7 September 2012, Counsel for the defence of the Accused filed a joint response.<sup>2</sup>
- 2. On 12 September 2012, the Trial Chamber deferred ruling on the Defence motions alleging defects in the form of the Indictment, until the Pre-Trial Judge had ruled on the Prosecution Request seeking leave to amend the indictment.<sup>3</sup> On 20 September 2012, the Prosecution replied to the Response.4
- On 25 October 2012, the Pre-Trial Judge granted leave to amend the confirmed 3. indictment,<sup>5</sup> inviting the Prosecution to file a new indictment incorporating some changes specified at paragraphs 35 and 36 of his Decision. The Prosecution duly filed, confidentially, the amended indictment with the changes ordered by the Pre-Trial Judge and it also sought authorisation to make two clarifications. On 26 November 2012, Counsel for Assad Hassan Sabra filed a Second Preliminary Motion Challenging the Form of the Indictment.<sup>7</sup>
- The Pre-Trial Judge has not yet ruled on the Prosecution's request for authorisation to make two clarifications to the amended indictment submitted on 9 November 2012. The Trial Chamber will therefore defer consideration of Sabra's second motion challenging the form of the indictment, until the Pre-Trial Judge has issued a final decision on the clarifications sought.
