# DECISION ON PROSECUTION'S REQUEST OF 15 MARCH 2013 TO AMEND EXHIBIT LIST — FORENSICS

### I. Introduction

1. In this decision, the Pre-Trial Judge rules on the Prosecution's request of 15 March 2013 to amend the exhibit list by adding certain items related to the Hariri crime scene and Forensic Project 33 (the "Request"). <sup>1</sup>

### II. Procedural History

- 2. On 15 November 2012, the Prosecution filed its pre-trial brief which included its list of witnesses and exhibits it intended to rely on at trial.<sup>2</sup>
- 3. On 21 December 2012, the Prosecution filed a request to amend the witness and exhibit lists, and for authorisation for further disclosure (the "21 December 2012 Request").
- 4. On 28 January 2013, the Prosecution filed a corrigendum to the 21 December 2012 Request.<sup>4</sup>
- 5. On 27 February 2013, the Pre-Trial Judge issued his decision on the 21 December 2012 Request.<sup>5</sup>
- 6. On 1 March 2013, the Prosecution filed another request to file an updated list of exhibits (the "1 March 2013 Request").
- 7. On 15 March 2013, the Prosecution filed the Request.
- 8. On 19 March 2013, the Pre-Trial Judge authorised the Prosecution to amend the exhibit list and the disclosure by the Prosecution of any previously undisclosed items that are added to the exhibit list by 15 April 2013 at the latest (the "19 March 2013 Decision").

#### III. Discussion

9. The Pre-Trial Judge notes that, by way of the Request, the Prosecution proposes to file (1) amendments to its exhibit list in several instalments over a period of six weeks, with the final instalment to be filed by 15 April 2013, and (2), an updated exhibit list relating to "the subject areas of the Hariri crime scene and Forensic Project 33" by 15 March 2013, as the first instalment. Since at the time of the Request the Prosecution was aware that the Pre-Trial Judge had not yet issued his decision on the 1 March 2013 Request, it is seeking leave to amend its exhibit list by adding items listed in Annexes A and B related to the Hariri crime scene and Forensic Project 33.9

10. The Pre-Trial Judge recalls that the 19 March 2013 Decision addressing the 1 March 2013 Request authorised the Prosecution to amend the exhibit list through a series of instalments organised by subject area and furthermore authorised the disclosure of any previously undisclosed items by 15 April 2013. As the 1 March 2013 Request referred *inter alia* to the Prosecution request to file an updated exhibit list relating to the Hariri crime scene and Forensic Project 33, the Pre-Trial Judge considers that the 19 March 2013 Decision has already dealt with the Request.

11. The Pre-Trial Judge considers that the Request is therefore moot.
