Mr. David Young Mr. Guénaël Mettraux The Defence of Mr. Mustafa Amine Badreddine, Mr. Hussein Hassan Oneissi, and Mr. Assad Hassan Sabra have each filed motions under Rule 90 (A) (ii) of the Rules of Procedure and Evidence challenging the form of the amended indictment of 6 February 2013. The Prosecution asks for an extra three working days to respond, and to increase the word limit permitted in a single filing to 12,000 words so as to file a consolidated response to the three motions. No response to the Prosecution request was filed. The Trial Chamber agrees with the Prosecution's submission that allowing the request will enhance judicial economy and avoid unnecessary duplication of the resources of the Prosecution and the Tribunal, and hence:

FOR THESE REASONS the Trial Chamber:

(i) EXTENDS the word limit for a consolidated response to the Defence motions to 12,000 words, and extends the time for filing to 24 May 2013 by 16.00 hrs.
