CONSIDERING that, on 31 July 2013, the Pre-Trial Judge rendered a decision on the Prosecution request of 21 June 2013 to amend the Indictment of 6 February 2013¹ (the "Decision");

CONSIDERING that the Decision was classified as "public";

CONSIDERING that some of the information contained in the Decision might compromise the smooth running of ongoing investigations and/or the protection of any person;

CONSIDERING that the Decision must therefore be classified as "confidential" and a redacted version of it made public;

CONSIDERING that, furthermore, a clerical error appears at paragraph 11 (i) of the Decision in that reference is made to the date of 15 January 2013 instead of 15 January 2005;

CONSIDERING that this clerical error should be corrected;

FOR THESE REASONS,

Pursuant to Rules 77 and 96 (B) of the Rules of Procedure and Evidence and Article 7 (6) of the Practice Direction on Filing of Documents before the Special Tribunal for Lebanon,

THE PRE-TRIAL JUDGE,

ORDERS the Registrar to reclassify the Decision into the category of "confidential";

STATES that the date of 15 January 2013 contained at paragraph 11 (i) of the Decision is to be replaced by the date of 15 January 2005;
