## SCHEDULING ORDER FOR THE DEFENCE TO FILE PRELIMINARY MOTIONS CHALLENGING THE FORM OF THE AMENDED INDICTMENT OF 21 JUNE 2013

- 1. The Defence for Messrs Badreddine, Oneissi and Sabra each filed requests for certification to appeal the Trial Chamber's decision of 12 June 2013, in which it dismissed their preliminary motions alleging defects in the form of the indictment.<sup>2</sup>
- 2. On 5 July 2013, the Trial Chamber issued its decision granting the requests for certification for Messrs Badreddine, Oneissi and Sabra.<sup>3</sup>
- 3. After the Appellate Briefs from the Defence for Messrs Badreddine, 4 Oneissi 5 and Sabra, 6 had been lodged but prior to a decision being rendered by the Appeals Chamber, the Pre-Trial Judge granted leave to the Prosecutor to amend the indictment.<sup>7</sup> Thereafter, the Prosecutor filed a new amended indictment on 2 August 2013.8
- 4. On 5 August 2013, the Appeals Chamber issued its "Decision on Defence Appeals Against Trial Chamber's 'Decision on Alleged Defects in the Form of the Amended Indictment'", 9 dismissing the appeals as moot because the previous indictment, on which the appeals were based, had fallen away with the filing of the new amended indictment on 2 August 2013. 10

- 5. The Appeals Chamber further declared that the Defence, if they wish, may file preliminary motions before the Trial Chamber directed at the amended indictment of 21 June 2013 (filed 2 August 2013).<sup>11</sup>
- 6. If the Defence for Messrs Ayyash, Badreddine, Oneissi and Sabra wish to follow the Appeals Chamber Decision, submissions should be filed no later than 19 August 2013.
