I, David Baragwanath, PRESIDENT of the Special Tribunal for Lebanon ("Tribunal");

CONSIDERING the resignation of Judge Robert Roth, the Presiding Judge of the Tribunal's Trial Chamber, on 9 September 2013;

NOTING that Article 8(3) of the Statute of the Tribunal stipulates that "[a]t the request of the presiding judge of the Trial Chamber, the President of the Special Tribunal may, in the interest of justice, assign the alternate judges to be present at each stage of the trial and to replace a judge if that judge is unable to continue sitting;"

MINDFUL that the four remaining Judges of the Trial Chamber – Judge Janet Nosworthy (Alternate Judge), Judge Walid Akoum (Alternate Judge), Judge Micheline Braidy and Judge David Re – jointly wrote to me on 9 September 2013 requesting that I "take all necessary steps according to Article 8(3) of the Statute of the Tribunal to ensure that the international Alternate Judge, Judge Janet Nosworthy, is appointed as a Judge of the Trial Chamber," so as to "allow the Trial Chamber to continue functioning;"

CONSCIOUS that on 1 February 2012 the Trial Chamber has ordered *in absentia* proceedings in the case *Prosecutor v. Salim Ayyash, Mustafa Badreddine, Hussein Oneissi and Assad Sabra* (Case No. STL-11-01);³

CONSIDERING that the Trial Chamber is now seized of several matters in the *Ayyash et al.* case under Rule 89(E) of the Tribunal's Rules of Procedure and Evidence;⁴

FURTHER NOTING that the Trial Chamber is currently seized of motions by Defence counsel for Messrs Badreddine, Oneissi and Sabra alleging defects in the form of the newly amended indictment of 21 June 2013:⁵

MINDFUL that the Pre-Trial Judge has set a tentative start date for trial in the *Ayyash et al.* proceedings of 13 January 2014;⁶

EMPHASISING that under Article 16(4)(c) of the Tribunal's Statute, the accused have the right to be "tried without undue delay" and that the Statute further emphasises in Articles 18(2) and 28(2) a policy of "fair and expeditious trial";

CONVINCED of the vital importance of the Trial Chamber's work proceeding as efficiently and expeditiously as possible;

PURSUANT to Article 2(3)(b) of the Annex to UN Security Council resolution 1757 (2007), Articles 8(3) and 10(1) of the Tribunal's Statute, and Rules 28 and 32(B) of the Tribunal's Rules of Procedure and Evidence;

Hereby:

ASSIGN Judge Janet Nosworthy to replace Judge Roth as sitting Judge of the Tribunal's Trial Chamber, with immediate effect.
