On 19 September 2013, the Appeals Chamber issued confidentially its "Decision on Appeal by Counsel for Mr Oneissi against Pre-Trial Judge's 'Decision on Issues Related to the Inspection Room and Call Data Records'". We indicated in paragraph 5 of that Decision that we would issue a public or public redacted version once the Pre-Trial Judge had assessed the matter of confidentiality for his decision, which was the subject of the appeal.
