I, David Baragwanath, PRESIDENT of the Special Tribunal for Lebanon ("Tribunal");

**NOTING** my Order of 10 September 2013 on the composition of the Tribunal's Trial Chamber, whereby I appointed Judge Janet Nosworthy as a sitting judge of the Trial Chamber following the resignation of Judge Robert Roth on 9 September 2013;<sup>1</sup>

**NOTING** that the United Nations ("UN") Secretary-General offered Judge Nicola Lettieri an appointment as an alternate judge of the Tribunal's Trial Chamber on 7 January 2014;<sup>2</sup>

FURTHER NOTING that Judge Lettieri accepted this appointment on 8 January 2014;<sup>3</sup>

**CONSIDERING** that Article 8(3) of the Statute of the Tribunal stipulates that "[a]t the request of the presiding judge of the Trial Chamber, the President of the Special Tribunal may, in the interest of justice, assign the alternate judges to be present at each stage of the trial and to replace a judge if that judge is unable to continue sitting";

**MINDFUL** of the recent request of the Presiding Judge of the Trial Chamber that, pursuant to Article 8(3) of the Statute of the Tribunal, I assign Judge Lettieri, upon his taking office, to the Trial Chamber to be present at each stage of the trial;<sup>4</sup>

**RECALLING** that Judge Lettieri was sworn in as a Judge of the Tribunal earlier today, on 15 January 2014;

**CONSCIOUS** that trial in *Prosecutor v. Salim Ayyash, Mustafa Badreddine, Hussein Oneissi and Assad Sabra* (Case No. STL-11-01) will commence on 16 January 2014;

**CONSCIOUS** that the Trial Chamber in *Prosecutor v. Hassan Habib Merhi* (Case No. STL-13-04) is seized of a request to join this case with the *Ayyash et al.* case;<sup>5</sup>
