**ORDERS** that the text of the public transcript of the hearing dated 24 January 2014 (p.24, line 15 and line 18) shall be omitted.

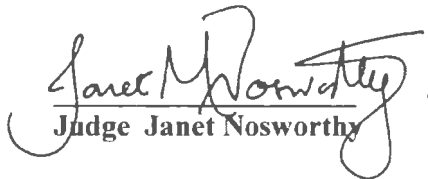
**NOTES** that a portion of the video broadcast of the hearing dated 24 January 2014 was not transmitted to the public and will be restored for public record later.

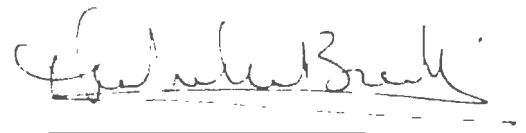
