#### ORDER DESIGNATING CONTEMPT JUDGE

MADE PUBLIC BY PRESIDENT'S ORDER DATED 23 MAY 2014

- 1. In my capacity as Contempt Judge, I issued today an Order in Lieu of an Indictment against *New TV* S.A.L., the legal person doing business as *Al Jadeed* TV, and Ms Karma Khayat, *Al Jadeed's* Deputy Head of News and Political Programmes Manager. In my Decision I recused myself from further hearing the case. This requires the designation of a new Contempt Judge to adjudicate upon the matter.
- 2. I recall that under Rule 60 *bis* (C) of the Rules, "[t]he President shall designate a Contempt Judge in accordance with the relevant Practice Direction to hear cases of contempt and obstruction of justice". Pursuant to Article 1 of the Practice Direction,<sup>3</sup> the President designates the Contempt Judge from a pre-determined roster of all Judges of the Tribunal. This roster is organized by Judges' names and provides for each Judge of the Tribunal to be the Contempt Judge within a pre-determined calendar month. Once designated, the Contempt Judge remains seized of the matter until it is finalized.<sup>4</sup> For the month of January 2014, the roster provides for Judge Nicola Lettieri as the Contempt Judge. Accordingly, I designate him Contempt Judge in this matter.
- 3. Because the Order in Lieu of an Indictment remains confidential and *ex parte* until further order,<sup>5</sup> this Order designating the new Contempt Judge must also have the same status at this stage.
