## ORDER RESCHEDULING INITIAL APPEARANCES

1. At the oral hearing of 13 May 2014, I rescheduled the initial appearances of the Accused in this case to 29 May 2014, 9.30 am and 10.30 am, respectively.<sup>1</sup> This followed a request by Mr Al Amin to postpone his initial appearance and after hearing the *amicus curiae* Prosecutor and the Head of Defence Office.

2. The Head of Defence Office now requests that the initial appearances be moved to the afternoon given that he will only return from a business trip that morning.<sup>2</sup> *Amicus* does not object to this request.<sup>3</sup>

3. I note that while it would have been preferable for the Head of Defence Office to inform me of this scheduling conflict when I invited him to comment on the proposed time during the hearing<sup>4</sup> I nevertheless find it in the interests of justice to ensure his presence during the initial appearances and grant his request. I also clarify that for purposes of judicial economy there will be one hearing with the initial appearances of both Accused.

## FOR THESE REASONS,

**I GRANT** the request and **ORDER** that the initial appearances of both Accused take place before me on 29 May 2014, at 3 pm.
