1. On 31 January 2014, I, as the Contempt Judge, issued the “Redacted Version of Decision in Proceedings for Contempt with Orders In Lieu of an Indictment”, which included an order in lieu of an indictment against *New TV S.A.L.* and Ms Karma Mohamed Tahsin Al Khayat.¹ In my Decision, I recused myself from further hearing this case.² This required the designation of a new Contempt Judge to adjudicate upon the matter.

2. Consequently, on the same day, pursuant to Rule 60 *bis* (C) of the Tribunal’s Rules of Procedure and Evidence (“Rules”) and Article 1 of the Practice Direction on Designation of Judges in Matters of Contempt, Obstruction of Justice and False Testimony, I, as President, issued the “Order Designating Contempt Judge”, whereby I designated Judge Nicola Lettieri as the new Contempt Judge in this case.³

3. Because the Decision remained confidential and *ex parte* at that time pursuant to Rule 74, the Designation Order was also classified as confidential and *ex parte*.⁴ Since then, Judge Lettieri has lifted the confidential and *ex parte* classification of my Decision.⁵ Accordingly, there is no longer reason to maintain the confidential and *ex parte* classification of the Designation Order.

DISPOSITION

FOR THESE REASONS;

PURSUANT to Rule 96;

I

ORDER the lifting of the confidential and *ex parte* classification of the following document:
