SCHEDULING ORDER FOR PRE-TRIAL BRIEFS

- 1. By way of this order, I am setting a date for the filing of the pre-trial briefs for the *Amicus Curiae* Prosecutor ("*Amicus*") and the Defence, in accordance with Rule 91 of the Rules of Procedure and Evidence ("Rules").
- 2. Rule 91(G) of the Rules states that the Prosecution must file its pre-trial brief and its lists of witnesses and exhibits at least six weeks before the Pre-Trial Conference held under Rule 127 of the Rules. Similarly, Rule 91 (I) requires that the Defence file its pre-trial brief no later than three weeks before the Pre-Trial Conference, in order to address factual and legal issues including the general nature of the accused's defence, matters under dispute in the *Amicus*' pre-trial brief, and why each of those matters are in dispute.²
- 3. Earlier today, I delivered a decision disposing of a motion challenging jurisdiction in this case.³ I note *Amicus Curie* Prosecutor's submission that pre-trial briefs should only be filed once any appeal against this decision has been decided.⁴ However, I find that it is in the interests of justice to set the dates for the pre-trial briefs at this stage so that the proceedings may progress expeditiously towards trial.
- 4. A Pre-Trial Conference and subsequent date of the commencement of this contempt trial will be set in due course, after consultation with the Parties, bearing in mind that certain applicable time limits will be shortened.⁵
