## SCHEDULING ORDER FOR A STATUS CONFERENCE

- 1. On 29 May 2014, I ordered the Head of Defence Office to assign counsel to the Accused. On 18 June 2014, I ordered the Accused to make submissions on whether they intended to participate in the proceedings against them and, if so, whether they would represent themselves or appoint counsel of their choosing. However, they failed to respond to my questions.
- 2. On 17 July 2014, I issued a Scheduling Order informing the Parties that a Status Conference would be convened after the judicial recess in order to address these issues and the case management towards trial.<sup>4</sup> I noted that the Accused would be invited to participate in the Status Conference and that they would be given another chance to clarify their intentions regarding these proceedings.<sup>5</sup>
- 3. On 18 August 2014 I received a Preliminary Motion by counsel assigned to represent the Accused,<sup>6</sup> followed by a Response from the *Amicus Curiae* Prosecutor ("*Amicus*") <sup>7</sup> and a further request by counsel to file a reply to the Response.<sup>8</sup>
- 4. In light of the above, I consider it prudent at this stage to hold a Status Conference in order to clarify the way forward as well as the state of pre-trial proceedings.
- 5. Therefore, pursuant to Rule 94 (A) of the Rules of Procedure and Evidence, I will convene a Status Conference on 12 September with the following agenda:
  - (i) Issues related to counsel's representation of the Accused;
