DECISION RESCINDING PROTECTIVE MEASURE GRANTED TO ONE PARTICIPATING VICTIM

INTRODUCTION

1. On 1 October 2014, the Legal Representative for Victims requested the Trial Chamber rescind the protective measure (anonymity) granted by the Pre-Trial Judge¹ to Victim V010 participating in the proceedings pursuant to Rule 133 and allow the Legal Representative for Victims to reclassify the identity of this Victim from confidential to public.² The Prosecution and counsel for the five Accused informed the Trial Chamber that they do not intend to respond to the motion.³ The Trial Chamber is satisfied that rescinding the protective measure granted to the Victim complies with the requirements of Rule 133.

DISCUSSION

- 2. Rule 133 provides, 'The Trial Chamber may, *proprio motu* or at the request of a Party, the victim or witness concerned, the Victim's Participation Unit or the Victims and Witnesses Unit, order appropriate measures for the privacy and protection of victims and witnesses, provided that the measures are consistent with the rights of the accused'. The same legal test accordingly applies when granting, varying or rescinding protective measures.
- 3. The Legal Representative for Victims submits that Victim V010 wishes to renounce the protective measures granted—as is confirmed in her written consent annexed to the motion⁴—as the Victim considers that the circumstances that prompted the initial request are no longer applicable. The initial request for protective measures was based on the political situation in the area where the Victim lived at the material time and past activities of politically affiliated groups in that area. According to Victim V010, 'the threat towards her has decreased' and she no longer feels the need to remain a confidential victim, even though the political situation in the area remains unchanged.⁵ In her written consent annexed to the motion, the Victim is asking the Trial Chamber to change her

status from confidential to public so that she can attend the court hearings in mid-October 2014 together with the Legal Representative for Victims.⁶

4. Having reviewed the motion in light of the requirements imposed by Rule 133, the Trial Chamber finds that the Legal Representative for Victims provides sufficient relevant information in relation to Victim V010. The Trial Chamber observes that the Victim consents to the rescission of the protective measure and is satisfied that reclassifying the information on the Victim's identity from confidential to public will not put the Victim at risk. The protective measure granted to Victim V010 is therefore rescinded.

DISPOSITION

FOR THESE REASONS, the Trial Chamber:

RESCINDS the protective measure granted to Victim V010 by the Pre-Trial Judge; and

ALLOWS the Legal Representative for Victims to reclassify the identity of Victim V010 from confidential to public.
