1. In an order issued on 7 October 2014, I scheduled the Pre-Trial Conference in these proceedings for 5 November 2014. ${ }^{1}$
2. I have however recently been informed of conflicting scheduling commitments which make the date of 5 November impractical. Taking into account trial management needs, and pursuant to Rules 60 bis (H), 77 (E), 89 (B) and 127 of the Tribunal's Rules of Procedure and Evidence ("Rules"), I thus re-schedule the Pre-Trial Conference for 3 November 2014 at 4:30 p.m. The dates of further hearings in the case will depend on the Parties' filings to be submitted prior to 3 November, and on the discussions between the Parties on that date.
3. Counsel for the Defence has also advised me- through my legal staff- that the Accused do not intend to participate in the Pre-Trial Conference. Considering the limited function of a pre-trial conference, which is akin to a status conference, ${ }^{2}$ I see no reason why the Accused need be present at the hearing if they wish not to be. For the same reasons, subject to the necessary arrangements with the Registry, appearances by the Parties may take place via-video-link.
