By way of that report, I submitted to the Trial Chamber all the documents filed by the parties and the victims participating in the proceedings, any evidentiary material received, the transcripts of the status conferences, the minutes of meetings held in the performance of my functions (Annex J), the orders and decisions rendered (Annex A), as well as the correspondence relating to the *Ayyash et al.* case (Annex B).

In the Annex to the report, I also provided a list of the applications that are currently suspended and that have been submitted to the Trial Chamber (Annex D), two lists of confidential and ex parte applications that are currently suspended and have been referred to the same Chamber (Annexes E and F), a list of the applications currently suspended relating to matters falling under my exclusive jurisdiction (Annex G), a list of confidential and ex parte applications that are currently suspended relating to matters falling under my exclusive jurisdiction (Annex H), as well as a list of the documents placed under seal and ex parte with limited distribution (Annex I).

On 3 July 2014, I filed an additional Annex relating to evidentiary material, correspondence, minutes of meetings, and decisions and orders (Annex K) falling within the context of Rule 92 of the Rules
