1. On 3 November 2014, pursuant to Rule 127 of the Tribunal's Rules of Procedure and Evidence, I held a Pre-Trial Conference. During the hearing, the *Amicus Curiae* Prosecutor ("*Amicus*") and the Defence made oral submissions on potential dates for the start of trial and presentation of the Parties' cases.¹ Due to outstanding disclosure and logistical issues, I determined that it was not yet appropriate to issue an order setting such dates and that I would soon hear further from the Parties.²

2. On 28 November 2014, in a decision on the admissibility of witness statements and records of interview, I ordered the *Amicus* to file, after consulting with the Defence and my legal officers, submissions proposing the time he will require for his case-in-chief.³ The *Amicus* did so on 8 December 2014.⁴

3. After considering the *Amicus*'s submissions, I proposed trial dates to the Parties with which they agreed.⁵ I also informed them that this schedule would be subject to further developments and submissions.⁶
