1. On 10 August 2012, the Pre-Trial Judge issued the confidential and ex parte "Order for Immediate Removal of Disseminated Material and Cessation of Dissemination" in the Ayyash et al. case ("Order"). He later filed a public redacted version of the Order. <sup>2</sup>

2. On 26 March 2015, the *Amicus Curiae* Prosecutor ("*Amicus*") requested that I lift the confidential and *ex parte* status of the Order.<sup>3</sup> The Defence has not yet filed a response, but in light of the nature of the matter and because no prejudice arises I can address the Request now.

3. The Request pertains to an order that the Pre-Trial Judge issued in the *Ayyash et al.* case. I note that the Trial Chamber is currently seized of those proceedings and is therefore the competent body to rule on the Request. I therefore refer the Request to the Trial Chamber.
