- 1. On 22 April 2015, the Defence sought admission into evidence of the documents it presented through the witnesses AP 04, AP 12 and AP 13.<sup>1</sup>
- 2. The *Amicus Curiae* Prosecutor ("*Amicus*") objected to the admission of the witness statements of witnesses AP 04 and AP 13. He also objected to the admission of the records of insurance companies shown to witness AP 13 and to the copies of screenshots of several websites shown to witness AP 12. The *Amicus* argued that all these documents lack relevance and should therefore not be allowed into the trial record.<sup>2</sup>
- 3. Having heard the Parties, I am satisfied that the documents to which the *Amicus* objects are relevant as they were shown to the witnesses with a view to challenging their credibility and reliability.
- 4. Indeed, I am satisfied that all the documents tendered by the Defence through witnesses AP 04, AP 12 and AP 13 are relevant and of probative value.
- 5. I note that the Parties agreed to the admission of a document, as shown in the annex to this Decision, pending translations by LSS.<sup>3</sup> Accordingly, this document will be admitted into the record as soon as LSS has provided the official translation.
- 6. Therefore, with the exception of the document for which official translation is pending, I admit the documents tendered by the Defence through witnesses AP 04, AP12 and AP13 into the trial record.
- 7. I note that witnesses AP 12 and AP 13 testified in closed session pursuant to my decision of 7 April 2015.<sup>4</sup> Accordingly and in order to protect the identities of these witnesses, the documents tendered during their testimony shall remain confidential, as indicated in the annex to this Decision.
