DECISION ON ADMISSION OF EXHIBITS RELATED TO WITNESS DT05

- 1. On 13 May 2015, the Defence requested the admission into evidence of the exhibits contained in its presentation queue for witness DT05 numbered 8, 9, 10, 11, 13, 16, 17, 18, 20 and 21 ("Request of the Defence").
- 2. On 14 May 2015, the *Amicus Curiae* Prosecutor ("*Amicus*") sought admission into evidence of the exhibits contained in his presentation queue for witness DT05 numbered 23, 24, 27, 28, 43, 44, 49 and 50 ("Request of the *Amicus*").²
- 3. Neither Party objected to the other's request.³
- 4. In light of witness DT05's testimony, I am satisfied that all the exhibits tendered by the Parties are relevant and of probative value.
- 5. I note that Defence presentation queue number 18 is identical to Defence presentation queue number 16, except that number 18 contains witness DT05's signature. It is therefore proper to admit only number 18 into the record.
- 6. I find that all the other exhibits tendered by the Parties may be admitted into evidence.

DISPOSITION

FOR THESE REASONS,

I

GRANT the Request of the Defence in part;

ADMIT the exhibits numbered 8, 9, 10, 11, 13, 17, 18, 20 and 21 in the Defence presentation queue for witness DT 05 into the trial record;

GRANT the Request of the *Amicus*;
