1. **NOTING** the “Decision in Respect of the Sabra Defence Request for Leave to Reply to the Prosecution Response”¹ in relation to its request for disclosure of a document, issued confidentially by the Pre-Trial Judge on 12 October 2015;
2. **NOTING** the public decision of the Pre-Trial Judge of 26 October 2015 relating to the request for disclosure of a document filed by the Sabra Defence;²
