1. Upon a request by the Defence ("Motion")<sup>1</sup> and an order communicated to the Parties by e-mail,<sup>2</sup> I directed the *Amicus Curiae* Prosecutor ("*Amicus*") to file public redacted versions of the confidential motions to amend his exhibit<sup>3</sup> and witness lists<sup>4</sup> and his confidential request for leave to file an addendum to the report of his expert witness.<sup>5</sup>

2. I subsequently granted the *Amicus*'s request to have reclassified to public his request for an addendum to the report of his expert witness<sup>6</sup> and I note that the *Amicus* has filed the public redacted versions of the other two motions.<sup>7</sup> Pursuant to Article 7 (5) (e) of the relevant Practice Direction<sup>8</sup>, the Defence now seeks the reclassification to public of its original Motion.<sup>9</sup> The *Amicus* has indicated that he does not oppose this request.<sup>10</sup>

3. Having reviewed the Motion, I am satisfied that it does not contain information that should remain confidential. I therefore order the reclassification of this filing to public.
