ORDER REQUESTING THE COOPERATION OF THE GOVERNMENT OF THE LEBANESE REPUBLIC TO CEASE DISSEMINATION AND

ORDER TO AKHBAR BEIRUT S.A.L. AND IBRAHIM AL AMIN TO IMMEDIATELY REMOVE MATERIAL AND CEASE DISSEMINATION

The Trial Chamber has received information from the Special Tribunal's Registrar, and has satisfied itself, that non-compliance with the Pre-Trial Judge's order of 5 June 2013, 'Order Requesting the Cooperation of the Lebanese Authorities to Cease Dissemination of Information', continues.¹

FOR THESE REASONS,

PURSUANT to Rules 77 (A), 130 (B), and 133 (A) of the Rules of Procedure and Evidence of the Special Tribunal for Lebanon and to Article 15 (2) of the Agreement between the United Nations and the Lebanese Republic on the establishment of a Special Tribunal for Lebanon.²

THE TRIAL CHAMBER

ORDERS

Akhbar Beirut S.A.L., its principals, employees, agents and affiliates, and Ibrahim Al Amin, its Editor-in-chief:

- (i) to comply with the Pre-Trial Judge's order of 5 June 2013 and to immediately remove from the website of *Al Akhbar* and from any other platforms which are accessible to the public any information which is the subject of that order, in particular:
 - (a) an article dated 15 January 2013 published on Al Akhbar's website:

(b) an article dated 19 January 2013, published on Al Akhbar's website:

(c) an article dated 10 April 2013, published on Al Akhbar's website:

[REDACTED]; and

(ii) to cease and to refrain from disseminating or publishing any confidential or purported confidential information or material allegedly related to witnesses before the Special Tribunal unless it has become public either during open session proceedings of the Special Tribunal, or by its order;

REQUESTS the Government of the Lebanese Republic:

(i) to direct the Prosecutor-General of Lebanon, or the appropriate authority, to:

(a) serve this order on **Ibrahim Al Amin** and the responsible officials of **Akhbar Beirut S.A.L**. and, and to obtain written evidence confirming their receipt of it;

and

(b) to take all necessary measures to execute this order and to stop and prevent the dissemination of information that breaches the Pre-Trial Judge's order of 5 June 2013; and

(ii) to provide the Special Tribunal's Registrar with:

(a) proof of service of this order on **Ibrahim Al Amin** and the responsible officials of **Akhbar Beirut S.A.L**; and

(b) proof that the relevant identifying information has been removed from the website in compliance with this order, including screenshots, and

REITERATES that those responsible for the disclosure of information in breach of the Special Tribunal's orders may be found responsible for violating Rule 60 *bis* of its Rules of Procedure and Evidence governing contempt and obstruction of justice.³

³ Rule 60 bis (A) of the Special Tribunal's Rules provides (relevantly): 'The Tribunal, in the exercise of its inherent power, may hold in contempt those who knowingly and wilfully interfere with its administration of justice, upon assertion of the Tribunal's jurisdiction according to the Statute. This includes, but is not limited to, the power to hold in contempt any person who: [...] (iii) discloses information relating to proceedings in knowing violation of an order of a Judge or Chamber [...]'.
