### DECISION ADMITTING DOCUMENTS AND STATEMENTS RELATING TO SALIM JAMIL AYYASH'S BMW AND MOBILE NUMBERS – WITNESSES PRH385, PRH304, PRH258, PRH112, PRH034 AND PRH550

## **INTRODUCTION**

1. The Prosecution seeks to admit into evidence eight statements from six witnesses, and ten documents relating to the ownership of the Accused, Mr Salim Jamil Ayyash, of a BMW, and some mobile numbers that he allegedly used.<sup>1</sup> The documents relate to a handset installed in the vehicle that Mr Ayyash allegedly used and mobiles that the Prosecution seeks to attribute to him, namely 'personal mobile phone' numbers 3523935 and ('PMP 935') and 3767165 ('PMP 165').<sup>2</sup>

2. Counsel for Mr Ayyash do not oppose the admission of the documents into evidence and do not seek to cross-examine the witnesses. They submit, however, that the Trial Chamber should also receive into evidence the statements of two other witnesses, Witnesses PRH331 and PRH682, whose evidence is relevant and probative, but were not included in the Prosecution's motion.<sup>3</sup> The Trial Chamber has sought additional submissions on this and will deal with it in a separate decision.<sup>4</sup>

# THE EVIDENCE

3. The Prosecution submits that Mr Ayyash purchased a navy blue model 532i BMW in February 2002 and provided PMP 935 and another ending in 617 as the contact numbers. Mr Ayyash sold the vehicle in December 2004, and PMP 935 was provided as the contact number for the sale. The SIM card of PMP 165 was used in the BMW's handset on 23 November 2002 and 1 and 6 September 2003, while PMP 935's was used on 16, 28 and 29 September 2004. On 20 November 2004 the BMW was involved in an accident. The Trial Chamber has received evidence related to an insurance claim made thereafter.<sup>5</sup>

4. After the accident, Mr Ayyash needed his vehicle repaired. The insurance company referred Mr Ayyash's family to a garage, where it was repaired. Two employees of the garage

then used their own mobiles' SIMs in the BMW's handset between 1 and 11 December 2004. This evidence is in the witness statements. One witness identifies Mr Ayyash from a photograph. Another witness is a Lebanese Government official who provides evidence regarding the system of vehicle ownership in Lebanon. Additionally, Prosecution investigator, Mr Toby Smith (Witness PRH550), photographed the BMW and the IMEI<sup>6</sup> of its handset. The Prosecution seeks to tender the statements under Rule 155 of the Special Tribunal's Rules of Procedure and Evidence without calling the witnesses to court for cross-examination.

5. The Prosecution also seeks to tender ten exhibits into evidence under Rule 154, without requiring witness to testify about them. There are nine documents that the Prosecution obtained from the Lebanese Director-General of Traffic, Truck and Vehicle Management Authority, via the Lebanese Prosecutor-General. These documents concern the vehicle's registration and inspection, taxes and fees paid, and identity documents and bills of sale. The other document is Mr Smith's photographs of the BMW. Confidential annexes A and B further explain the relevance and probative value of the statements and documents.

### **DISCUSSION**

6. The statements and documents are all relevant to the case. The Trial Chamber is satisfied that the ten documents are *prima facie* reliable and have probative value. This is uncontested. The witness statements do not concern the acts and conduct of the Accused as charged in the amended consolidated indictment, but rather, provide information relevant to attributing certain mobile numbers to Mr Ayyash. The statements are admissible under Rule 155 and comply with the Rule 155 Practice Direction.<sup>7</sup> The statements may be admitted under Rule 155 and the documents under Rule 154.

# **CONFIDENTIALITY**

7. The Prosecution seeks to maintain the confidentiality of the motion until witness summaries are read onto the court record, in case the witnesses seek protective measures. The Trial Chamber therefore orders the Prosecution and counsel for Mr Ayyash to file redacted

versions of their filings, or to have them reclassified as public, after the Trial Chamber has received the evidence.

#### **DISPOSITION**

#### FOR THESE REASONS, the Trial Chamber:

**DECLARES** admissible, under Rule 155, the statements of Witnesses PRH385, PRH304, PRH258, PRH112, PRH034 and PRH550 (Mr Toby Smith) described in annex A to the motion;

**DECLARES** admissible, under Rule 154, the nine documents obtained from the Lebanese Director-General of Traffic, Truck and Vehicle Management Authority relating to Mr Ayyash's BMW, and the photographs of the vehicle, as listed in annex B to the motion;

**DECIDES** that it will, at a suitable stage in the proceedings, formally admit these documents into evidence and allocate exhibit numbers to them;

**MAINTAINS** the confidentiality of the filings and annexes until the Trial Chamber has received the evidence; and

**DEFERS**, pending further submissions, a decision on the request by counsel for Mr Ayyash in their response to the motion, to admit two statements into evidence.


