ORDER ON SABRA DEFENCE MOTION FOR THE ADMISSION OF DOCUMENTS **RELATING TO AHMED ABU ADASS**

- 1. Counsel for Mr Assad Hassan Sabra have requested the admission of over 160 items into evidence. The material, which was distributed among the annexes to its motion, relates to the character, religious beliefs and habits of Ahmed Abu Adass and persons closely associated with him. The Prosecution opposed the motion and, among other things, identified the existence of a number of duplicate entries, items already admitted or declared admissible, and an item of which judicial notice had already been taken. The Sabra Defence replied but did not address the identified issues. As a result, the Trial Chamber requested the Sabra Defence to revise their annexes. Subsequently, counsel for Mr Sabra submitted an addendum to their original motion with revised annexes, to which the Prosecution responded, identifying further issues and problems with the Sabra Defence motion's annexes.
- 2. In light of the continued confusion relating to these annexes, and in the interests of judicial economy, counsel for Mr Sabra are ordered to refile their motion and annexes by 9:00 a.m., 6 March 2017. In this respect, the Sabra Defence must specify which items it seeks to have admitted and the annexes must be free from the typographical and other errors identified by the Prosecution. In addition, the tendered items must:
 - Be individually arranged in continuous numbered rows, and with columns addressing the following for each item:
 - o Item number;
 - Motion footnote number;
 - o Title of item:
