In its decisions of 20 and 26 October 2017, the Trial Chamber ordered the Parties to file public redacted versions of the confidential filings underlying each decision, or to have these filings reclassified as public.¹ Counsel for the Accused, Mr Hussein Hassan Oneissi, requested the Trial Chamber to reclassify from 'confidential' to 'public' seven of its filings, having received the consent of counsel for Mr Hassan Habib Merhi and Mr Assad Hassan Sabra with respect to those filings which they had co-signed with the Oneissi Defence.² The Prosecution did not object to the proposed reclassification.

FOR THESE REASONS, the Trial Chamber:

INSTRUCTS the Registry to reclassify from 'confidential' to 'public' the following filings:
