ORDERS FOLLOWING THE AYYASH DEFENCE'S WITHDRAWAL OF ITS APPLICATION TO ACCESS CONFIDENTIAL MATERIAL IN THE CASE AGAINST AL JADEED [CO.] S.A.L./NEW T.V. S.A.L. (N.T.V.) AND KARMA MOHAMED TAHSIN AL KHAYAT

- 1. On 18 September 2015, counsel for the Accused, Mr Salim Jamil Ayyash, requested the Trial Chamber to grant them access to all confidential, *inter partes* transcripts of hearings and filings in the *Case against Al Jadeed [Co.] S.A.L./New T.V. S.A.L. (N.T.V.) and Karma Mohamed Tahsin Al Khayat*, case STL-14-05. Counsel for the former Accused, Mr Mustafa Amine Badreddine, joined the Ayyash Defence's application, additionally seeking access to 'all statements' in the *Case against Akhbar Beirut S.A.L. and Ibrahim Mohamed Ali Al Amin*, case STL-14-06. The Prosecution responded on 29 September 2015 and the Ayyash Defence replied on 2 October 2015. Further to the Trial Chamber's invitation to the Parties in the STL-14-05 and STL-14-06 cases, the Defence for *Al Jadeed* S.A.L. and Ms Al Khayat and the *Amicus Curiae* Prosecutor in the *Al Jadeed* case also responded.
- 2. On 26 October 2017, the Ayyash Defence withdrew its application, due to the imminent closure of the Prosecution case, the Prosecution's non-reliance on certain evidence and the finalisation of the proceedings in the *Al Jadeed* case. Counsel for Mr Ayyash submit that this is without prejudice to resubmitting an application for access to materials at a later stage, should the need arise.⁵
- 3. The Trial Chamber therefore notes the withdrawal of the 'Partly Urgent Ayyash Defence Request for Access to Confidential Material in The Case STL-14-05', filing F2208.

Reiterating the public nature of the proceedings, the Trial Chamber orders the Prosecution and the Ayyash Defence to either file public redacted versions of their response and reply or to have them reclassified as public. The Trial Chamber also orders the Head of Defence Office, under Rule 57 (E) (iv) of the Special Tribunal's Rules of Procedure and Evidence, and the Registrar, under Rule 48, to ensure that public redacted versions of the responses of, respectively, the Defence for *Al Jadeed* S.A.L. and Ms Al Khayat, and the *Amicus Curiae* Prosecutor in the *Al Jadeed* case, are filed.
