DECISION DENYING PROSECUTION REQUEST TO REDACT 'DECISION GRANTING, IN PART, SABRA DEFENCE MOTION FOR THE ADMISSION OF DOCUMENTS RELATING TO MR AHMED ABU ADASS – CHARACTER, RELIGIOUS BELIEFS AND ASSOCIATES' AND ASSOCIATED FILINGS

BACKGROUND, SUBMISSIONS AND DECISION

1. On 25 September 2017, the Trial Chamber granted, in part, a motion by counsel for the Accused, Mr Assad Hassan Sabra, and admitted into evidence 49 documents relating to the character, religious beliefs and associates of Mr Ahmed Abu Adass.¹ The following day, the Special Tribunal's Court Management Services Section (CMSS), after the Victims and Witnesses Unit raised concerns about the public nature of the decision, limited access to it and subsequently removed it from the Special Tribunal's website.² It remains classified as 'public'.

2. The Prosecution seeks to redact, among other things, the names of individuals, potentially identifying characteristics, descriptions of evidence, titles of decisions relating to specific witnesses and witness pseudonym numbers from the Trial Chamber's decision and the Parties' associated filings. The proposed redactions to the decision and the Prosecution's submissions are included in annexes A to C of its motion.³ The Sabra Defence opposes the proposed redactions in their entirety.⁴

3. The Trial Chamber has carefully reviewed the proposed redactions to its decision and does not agree that it is in the interests of justice to adopt any of them. As the Sabra Defence has rightly pointed out,⁵ many of the names appear on transcripts or documents that are publicly available and the Sabra Defence has, throughout the trial, repeatedly named those allegedly involved in the recruitment and disappearance of Mr Adass. In other instances, the Trial Chamber has rejected protective measures for witnesses, such as for Mr Ziad Ramadan

(Witness PRH103).⁶ It is not convinced that the nature of the information contained in the decision regarding other Prosecution witnesses warrants the requested redactions.

4. Concerning the proposed redactions to the Parties' related filings,⁷ the Prosecution and the Sabra Defence are ordered to reconsider them, in cooperation, in light of this decision. The Parties should also consider the necessity of any redactions to the non-operative—but related—filings and their respective annexes.⁸

CONFIDENTIALITY

5. The Prosecution requests its motion and addendum, and presumably also the annexes to its motion, to remain confidential.⁹ The Sabra does not respond but notes that its response and annex were filed confidentially in light of the Prosecution's classification of its submissions.¹⁰

6. The Trial Chamber orders the Parties, working collaboratively, to consider anew—in light of this decision—whether any redactions are still needed to the Prosecution's motion and addendum and the Sabra Defence's response and their respective annexes. The Parties should file public redacted versions of these filings or apply to have them reclassified as public.

DISPOSITION

FOR THESE REASONS, the Trial Chamber:

DENIES the Prosecution motion;

INSTRUCTS the Registry to restore public access to F3337, Decision Granting, in Part, Sabra Defence Motion for the Admission of Documents Relating to Mr Ahmed Abu Adass – Character, Religious Beliefs and Associates, 25 September 2017;

ORDERS the Prosecution and the Sabra Defence—in cooperation—to reconsider the necessity of redactions to the related filings to the Trial Chamber's decision and to consider the necessity of redactions to the non-operative but related filings as per paragraph 4 above; and

ORDERS the Parties, in cooperation, to file a public redacted version of the Prosecution's motion and addendum—to the extent feasible—and the Sabra Defence's response and their respective annexes, or apply for their reclassification as public.
