- 1. On 5 March 2019, Defence counsel for Mr Salim Jamil Ayyash requested the Trial Chamber to change the classification of three confidential Ayyash Defence responses to public, pursuant to Article 7 (5) (e) of the Special Tribunal's Practice Direction on filings.<sup>2</sup>
- 2. The Trial Chamber has reviewed these filings and the initial grounds for classifying them as confidential, and it is satisfied that they can become public, considering also the absence of any objection from the Parties. Accordingly, the Trial Chamber **instructs the Registry** to reclassify from confidential to public the following filings:

  - (3) Ayyash Defence Response to "Prosecution Rule 154 Motion for the Admission of Records Received from the Traffic, Truck, and Vehicle Management Authority", filing F2807, dated 2 November 2016.
