1. **NOTING** the Prosecutor's Submission of 30 June 2011 requesting the Pre-Trial Judge to rule that the attacks committed against Messrs Hamade, Hawi, and El-Murr ("connected attacks") are connected to the attack committed against Mr Hariri on 14 February 2005;¹

- **NOTING** the Decision of the Pre-Trial Judge of 5 August 2011 ruling on the jurisdiction 2. of the Tribunal in respect of the connected attacks as a result of their being connected to the attack committed against Mr Hariri and of their nature and gravity being similar to that attack;²
- 3. NOTING the Order of the Pre-Trial Judge of 14 November 2011 ordering that the Decision on the Connected Case Submission, initially filed confidentially, be reclassified as a confidential and ex parte document;³
- 4. **NOTING** the Order of the Pre-Trial Judge of 12 October 2016 seeking information from the Prosecutor on the progress of the investigations relating to the connected attacks;⁴
- 5. CONSIDERING that the Pre-Trial Judge ordered the confidentiality of the filings above⁵ in order to ensure the security and safety of the victims and witnesses and to safeguard the Prosecutor's ongoing investigations and the integrity of the evidentiary material;⁶
- 6. NOTING Rule 96 (A) of the Rules of Procedure and Evidence ("Rules") according to which, subject to Rule 96 (B), all pre-trial filings, proceedings and orders shall be public;
- 7. **NOTING** the confirmation of an indictment, in case STL-18-10, against Mr Salim Jamil Ayyash for his role in the connected attacks⁷ and the filing of an amended version of the Indictment on 14 June 2019;8

8. **CONSIDERING** that the Pre-Trial Judge considers that the aforementioned filings must

also be filed in case STL-18-10, particularly due to the fact that they provide the basis for the

jurisdiction of the Tribunal in respect of the connected attacks, which are the subject of this last

case, and to the fact that the Defence may challenge that jurisdiction pursuant to Rule 11 (C) of

the Rules;

9. **CONSIDERING** that, for the same reasons, the Pre-Trial Judge's Orders directing the

Lebanese judicial authorities seized with the cases concerning the connected attacks to defer to

the Tribunal ("Orders for Deferral")⁹ and the Prosecutor's Request relating thereto¹⁰ must also

be filed in case STL-18-10;

10. **CONSIDERING** that in this context, and in order to anticipate the forthcoming stages of

the proceedings in case STL-18-10, it is appropriate for the Pre-Trial Judge to request

submissions from the Prosecutor relating to the lifting of confidentiality and, if necessary, of the

ex parte nature of the confidential filings referred to above;
