**Pre-Trial Chamber I** (“Pre-Trial Chamber” or “Chamber”) of the International Criminal Court (“Court”) issues the following order on the “Notification and Request by the Government of Libya in response to ‘Decision on Libya’s Submissions Regarding the Arrest of Saif Al-Islam Gaddafi’” filed on 22 March 2012.<sup>1</sup>

1. On 27 June 2011, the Chamber issued a warrant of arrest against, among others, Saif Al-Islam Gaddafi (“Mr Gaddafi”).<sup>2</sup> On 5 July 2011, the Registrar notified the Libyan authorities of a request for cooperation asking for their assistance in arresting Mr Gaddafi and surrendering him to the Court.<sup>3</sup>
2. On 23 January 2012, the Libyan authorities sought postponement of the surrender of Mr Gaddafi to the Court pending the completion of national proceedings in relation to other crimes against Mr Gaddafi.<sup>4</sup>
3. On 7 March 2012, the Chamber issued the “Decision on Libya’s Submissions Regarding the Arrest of Saif Al-Islam Gaddafi” dismissing the request for postponement of the Libyan authorities and requesting that they make their decision to surrender Mr Gaddafi to the Court and inform the Chamber accordingly within seven days of notification of the Arabic translation of the decision.<sup>5</sup>

4. On 22 March 2012, the Government of Libya notified the Chamber of its intention to challenge the admissibility of the case concerning Mr Gaddafi pursuant to Articles 19(2)(b), (5), and (6) of the Rome Statute ("Statute") by 30 April 2012 and requested that, pending a decision on this challenge, the Pre-Trial Chamber suspend its surrender request in relation to Mr Gaddafi in accordance with, *inter alia*, Article 95 of the Statute and Rule 58 of the Rules of Procedure and Evidence ("Request of the Government of Libya").<sup>6</sup>
5. The Chamber notes Regulations 24 and 34 of the Regulations of the Court.
6. In order to ensure the expeditious conduct of proceedings, the Chamber considers it appropriate to shorten the deadline for the submission of responses, if any, to the Request of the Government of Libya.



**FOR THESE REASONS, THE CHAMBER HEREBY**


**ORDERS** the Prosecutor and the OPCD to file their responses, if any, to the Request of the Government of Libya by 30 March 2012.

Done in both English and French, the English version being authoritative.


